will be permitted. No reserves are allowed.

Boxers over 19 years up to 40 years are eligible.

Medical & Weigh-in

General weigh-in and medical examination of

all boxers will be held at the venue from 1600-1800 hrs.

on November 3, 2016 and on subsequent days

Draw : Draw will be held immediately on completion of

the medical & weigh-in on November 3, 2016.

Team Eligibility : Bhiwani-3, Rohtak-2, Panipat-2, Hisar-2 Team and other 1 team.

Team officials : Only one Coach, one Manager (Female) and one R/J will

be allowed per team.

Boarding/Lodging : Free lodging will be provided to all boxers and officials from

November 3-6, 2016.

Arrival particulars : The organisers will have their reception booth

at Rudkee Railway Station/Bus Stand.

Important

 The team/officials shall not arrive at venue earlier than the November 03 and shall leave by November 6, 2016.

Cost of travel of all participants and team officials upto Rurkee will be borne by the respective units.

3. In case of extra member in a team, a charge of Rs. 500/- per day will be levied per head per day.

4. All boxers must possess their own Gum shield.

5. No teams will be allowed to participate unless Affiliation/Entry fees are paid to HSBA.

6. The championship will be conducted as per Boxing India rules.

 Every team must have to deposit Rs. 2,000/- as security deposit for accommodation and the same will be refunded after the event is over.

8. The HSBA Referee / Judge exam will be conducted during the championship.
